# EUROPE AND AFRICA PHARMANEX® BIOPHOTONIC SCANNER PROGRAMME SUMMARY

## **Scanner Qualification Requirements:**

- Be a Brand Representative
- Have 2,000 Group Sales Volume (GSV) in one month
- Completed the Pharmanex Biophotonic Scanner Task on Learning Center
- Submit the Scanner Qualification Request form<sup>1</sup> to your local Account Manager.

After your Account Manager has confirmed your qualification for a Pharmanex® BioPhotonic S3 Scanner, your Scanner Lease Agreement will be sent shortly to you and you will have 30 days to sign the Scanner Master Lease and License Agreement.

## **Scanner Lease Setup Costs:**

- Down payment<sup>4</sup>: 1,029 RON
- Shipping fee: 211,77 RON + VAT
- Monthly lease fee<sup>5</sup>: 315.81 RON + VAT
- Loss & Damage waiver fee (Compulsory)<sup>6</sup>: 67.02 RON + VAT
- Lease term: undetermined<sup>7</sup>

#### **Scanner Lease Details:**

- The Scanner Lease Holder:
  - ✓ The Scanner is not delivered with a mobile device. Lease Holder shall bear responsibility for downloading the S3 Scanner Application and maintaining a functioning mobile device in order to operate the Scanner.
  - The lease of the Equipment and the license of the Pharmanex Scanner Application are subject to Lease Holder maintaining its Brand Representative title and have six (6) Scanner related ADR SUBSCRIPTION registered monthly or achieve minimum of 8 building blocks on a monthly basis 9
  - shall ensure that no scan is performed without having obtained first a signed Consent from the customer, whereby the customer authorises Nu Skin to process their scan results.
  - ✓ shall always focus on the right target: People who are 18+ with an open mindset towards supplementation and a healthy dietary lifestyle.
  - ✓ must purchase physical (via the Nu Skin website www.nuskin.com) or digital Scan Cards¹⁰ (only via the S3 Scanner Application).
  - ✓ shall ensure that the device has access to the internet at least once, every 14 days. It
    is recommended for Lease Holder to connect the Equipment to the internet while the
    Equipment is in use.

### **Scanner Operator Bonuses:**

The Scan Operator Bonus is an incentive paid on qualified Skin Carotenoid Score (SCS) certified product Automatic Delivery Rewards (ADR). The ADR must be linked to a valid new initial or rescan scan number and the product must be fully paid and shipped to the customer<sup>11</sup>.

- Re-scan Bonus<sup>13</sup>: €7.5

#### **Free Scanner Programme:**

The Free Scanner Programme is a promotion where the Scanner Lease Holders can benefit from having their monthly lease fees waived upon meeting the Requirements listed below. The first lease payment is mandatory. This will be collected on the 7th calendar day of the month after the month in which the Scanner was allocated. Qualification for the Free Programme must be achieved separately each calendar month<sup>14</sup>.

To be considered for the month requested, this form must be received by email or by fax by the last working day of the month.

Nu Skin considers your lease termination as effective as soon as your Scanner is returned to Nu Skin, not when your Lease Termination form is sent back. The equipment shall be properly packaged and fully insured at your expense in the same operating order, condition, and appearance as on the date you received it. If the Scanner is returned to Nu Skin latest 15<sup>th</sup> of the month, no rental payment/loss and damage waiver will be requested for the month of the return.
- <sup>8</sup> The S3 Scanner Application 3.0 version is developed for OS 12 and above, iPhone and iPad. The S3 Scanner Application 2.0 version is developed for OS 11 and above, only iPad.
